THE WARRANTY PERIOD WILL BEGIN ON THE DATE OF DELIVERY TO THE CUSTOMER AND IS VALID FOR THE ORIGINAL PURCHASER. Warranties and service contracts may not be transferred to any other party.

Sealoc will repair or replace this product, at our option and at no charge, with new or reconditioned parts or products if found to be defective during the first three (3) years of the limited warranty period.
